3. The interest on recurring fixed deposit shall be accrued on daily basis and capitalized on monthly basis to the principal amount of recurring fixed deposit.
4. The accumulated principal amount (including interest amount) of Recurring Fixed Deposit will be credited to the above mentioned Account holder's operative account on maturity / next working day only.
5. In case of deferral of the recurring deposit, the final amount shall differ from the commitment amount.
