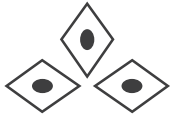

Your statement to the effect that such a payment has been made by you under the guarantee referred to therein, shall be conclusive and binding on us without any proof being called upon or without any details/explanation required.

In the event we fail to discharge our liability to the Bank under this indemnity the Bank shall be entitled to exercise its lien existing on any of our accounts maintained with any branch of the Bank or through liquidation/sale of our shares, securities or funds maintained in our accounts with the Bank whether through pledge to the Bank or being received by the Bank on our behalf within the course of banking or any other security hypothecated or mortgaged to the Bank on our behalf for any credit facility to the Bank and appropriate the same to recover entire dues, including interest charges, fee etc. thereof to discharge us from liability and this indemnity.
